
General Objective of the NGO Fund:

"Strengthened civil society development and enhanced contribution to social justice, democracy and sustainable development"

NGO Fund shall contribute to the overall objectives of the EEA Financial Mechanism to reduce economic and social disparities in the European Economic Area and to strengthen bilateral relations between Romania and the donor states Iceland, Liechtenstein and Norway.

Components and financial allocations

25,500,000 Euro to be distributed to project promoters

Component ENGAGE

 Objective: to encourage active citizenship and participation in community life, to ensure the respect and practice of fundamental democratic values.

Subcomponents:

- Participation in decision-making and community engagement
- Volunteer
- Encouraging democratic values

Component SOCIAL JUSTICE

 Objective: to contribute to combating social exclusion and widening disparities within society and between various groups of society such as some affluent urban centers and small urban and rural areas.

Subcomponents:

- Rural interethnic communities development
- Fighting social inequalities, poverty and exclusion.

Component SUSTAINABLE DEVELOPMENT

 Objective: to support sustainable development and the improvement of the environment in Romania through the contribution of the NGOs and through public participation

Component WELFARE AND BASIC SERVICES

 Objective: to increase access to and provision of welfare and basic services to vulnerable groups

Component NGO CAPACITY DEVELOPMENT. NETWORKS AND COALITIONS

 Objective: to support the overall development of the NGO sector in Romania as well as the development of effective networks, coalitions and think tanks.

Subcomponents:

- Support for coalitions and networks at regional and national level and for think tanks

- Support for initiatives that contribute to an enabling environment for NGOs in Romania and strengthen the overall sector representation

- Strengthening membership and volunteer base of organisations and increase participation of members/volunteers in organisation activities

Horizontal concerns:

- hate speech,
- extremism and hate crime,
- racism and xenophobia,
- homophobia,
- anti-Semitism,
- tolerance and multicultural understanding,
- Roma,
- sexual harassment,
- violence against women
- trafficking.

Types of grants:

Three types of grants will be supported:

- Small grants: from 5,000 to 35,000 Euro
- Medium grants:
- Large grants:

from 5,000 to 35,000 Euro from 35,001 Euro to 75,000 Euro from 75,001 Euro to 150,000/250,000 Euro

Duration: minimum 6 months, maximum (estimately) 18 months
